Prohibitions against Scheduled Castes in India: Severe restrictions were imposed on the scheduled castes, also called dalits today, since early periods, like not allowing them to wear shirts or vests, not to use ornaments, sandals and umbrellas, to use only earthen-ware vessels in homes, not to enter cities after sun-set and before sunrise, and keep a prescribed distance of steps from upper-caste Hindus.
